Eligibility

- Invest in active NZ assets (companies, equities, or funds)
- Stay minimum 21 days during the 3-year Growth period
- Transfer funds within 6 months of AIP approval
- Transfer funds within 6 months of AIP approval
- Include spouse and dependent children up to age 24.

- 2 Submit EOI outlining your investment plan and financial background
- 3 Receive AIP with a 6-month window to transfer investment funds
- 4 Invest NZD 5M in approved growth investments in New Zealand
- 5 Visa approved after verification, allowing family to live, work, and study

Minimum Investment :

NZD 10 million

Stay Requirement :

105 days over 5 years

Investment Duration :

5 years

- Includes all Growth category investments plus listed equities, bonds, philanthropy, and certain property developments (e.g., new residential projects that increase housing stock, or commercial/industrial developments that add value)
- This pathway offers a secure and structured route to residency, allowing investors and their families to live, work, and invest in New Zealand while benefiting from its stable economy and high quality of life.

Process

- 1 Check eligibility: 18+, clean record, medical clearance, and lawful funds
- 2 Submit EOI with investment plan and financial details
- 3 Receive AIP with a 6-month fund transfer window
- 4 Invest NZD 10M in approved diversified assets in New Zealand
- 5 Visa approved after verification, allowing family to live, work, and study



Business Investor Visa

The New Zealand Business Investor Work Visa is designed for experienced entrepreneurs looking to invest in and actively manage a business in New Zealand.

With a minimum investment of NZD 1 million, or NZD 2 million for a faster residency pathway, this program offers a clear route to residency, allowing investors and their families to live, work, and build a business in a stable and business-friendly environment.

Eligibility

- Invest NZD 1M (or NZD 2M for fast-track residency)
- Maintain NZD 500K for personal living expenses
- Age 55 or below with basic English proficiency
- Funds must be legally earned and owned
- Invest in and actively manage a NZ business

Processing Time:

1–2 months

Minimum Investment :

NZD 1 million

Stay Requirement :

184 days a year

Investment Duration :

1–3 years (based on investment)

Process

- 1 Assess eligibility and select a suitable existing business in New Zealand
- 2 Complete financial, legal, and operational due diligence
- 3 Submit visa application with all required documents
- 4 Transfer funds and purchase the business within required timeline
- 5 Actively manage the business and apply for residency after 1–3 years
